## TO WHOM SO EVER IT MAY CONCERN


We Versha Goyal, Company Secretary of Agribio Spirits Limited (Transferee company), and Jaishree Motwani, Company Secretary of Agribiotech Industries Limited (Transferor Company) hereby undertake on behalf of the entities that no action taken/pending by Govt./Regulatory body/Agency against the entities involved in the scheme for the period of recent 8 years except the following cases against Agribiotech Industries Limited as under:-

1. The Rajasthan State Excise Department has raised the demand of Rs. 1770.72 Lakhs on presumptive basis vide various Demand Recovery Notices on account of non-verification of some of Export permits (relating to interstate sales) issued by the Excise Authority of importing States. Further the Rajasthan State Excise department has raised the demand of Rs. 336.40 Lakhs on account of interest for delay in payment of state excise demand. The Company has deposited total amount of demand including interest in various years.

Out of total demand (including interest) as mentioned above the company has charged Rs 630.56 Lacs to profit & loss account upto 31.03.2012 in respective year of payment made. However, based on legal opinion, the remaining amount Rs 1476.56 Lacs has been shown as recoverable vide Note No. 7 under the head "Other Non-Current Assets" as the demand is sub-judice before appellate authorities. During the financial year 2022-23 the demand has been confirmed by the appellate authority therefor the company has made the provision of Rs 1476.56 Lacs and charged the same from retained Earning under Other Equity Capital. The company has filed the case before the Hon'ble High Court against the said order and the same is profiled for decision.

The appellate authority allowed to release the land by placing fixed deposit of Rs. 838.35 lakhs with department, accordingly the company has placed the fixed deposit of 838.35 Lakhs under been pledge with the department in FY 2023-24.
